- •Our shareholders approved the re-appointment of Deloitte & Touche, an independent registered public accounting firm, to act as our independent auditors for the fiscal year ending December 31, 2022 and authorized our Board of Directors, acting through our Audit Committee, to fix the remuneration of our independent auditors for the fiscal year ending December 31, 2022.
